Advokate is a volunteer organization formed in honor of Kate Hrischuk of Rochester, MI, who lost her courageous battle with an intrinsic brain stem glioma in early 2007 at age 6. It was founded by Kate's parents whom have taken on the mission to raise awareness about the issue of limited available research on the disease that took their daughter's life. Through the run, the organization has raised more than \$200,000 for St. Jude, where Kate and her family received priceless care and support.
